### **End-User License Agreement for STR Software**

# Attention: PLEASE READ THIS SOFTWARE LICENSE AGREEMENT CAREFULLY BEFORE INSTALLING OR USING THE SOFTWARE

By installing, copying, downloading, accessing, or otherwise using the STR Software, you agree to be bound by the terms and conditions of this License Agreement. If you do not agree to the terms of this License Agreement, do not copy, install, or use the Software, return the hard copy to your place of purchase and/or destroy all the downloaded files of the Software for a full refund.

#### 1. Definitions

When used in this End-User License Agreement, hereafter "License Agreement", the terms listed below shall have the following meanings:

"STR Software" or "Software" means the computer software program as it is described in the Code Description of the Software, any user documentation, hardware based key providing anti-piracy protection and licensing the Software, the license key code initiating the license, and other accompanying materials including any updates and upgrades thereto, delivered to you (either an individual or a single entity), as an end-user of STR Software, hereafter "You" or "End-User"

"Install" means to copy the Software to a hard disk drive or a similar storage device.

"Use" employed in relation to the Software means loading the Software into computer memory or running the Software on a central processing unit.

"Updates and Upgrades" means all new versions, modifications, and refinements that are incorporated into and make a part of the Software.

"Licensor" means the owner of the intellectual property rights on the STR Software or the entity entitled by the owner of intellectual property rights to commercialize the STR Software and have it distributed through its network of local distributors.

STR IP Holding, LLC, a Virginia limited liability company duly organized and existing under the laws of the State of Virginia, USA, is the owner of STR Software products.

"STR Distributor" means either the entity entitled by STR IP Holding, LLC to commercialize the STR Software or the local distributor within its network designated in the quotation for the delivery of STR Software to You.

"License" means the right to Use the Software You are granted by STR Distributor on the terms and conditions of this License Agreement.

"License Period" means the certain period within which You are granted the right to Use the Software. The License Period begins from the day the license key code is submitted by STR Distributor to You and expires according to the term or date specified in the Quotation of STR

Distributor to You.

"License Fee" means the price You are charged by STR Distributor for the Use of the Software during the term of the License Period as set forth in the Quotation of STR Distributor to the End-User. The License Fee includes support services, as described in Section 5 herein, provided by Distributor during the License Period.

**"Designated Site"** means the End-User's physical location identified in the Quotation of STR Distributor and is where the STR Software is authorized by STR Distributor to be used.

"Designated Network" means a local area network which is accessed and used only at the Designated Site of the End-User or within a 25-mile (40 km) radius of the Designated Site and within the same country as the Designated Site.

# 2. Scope of License

Subject to all of the terms and conditions of this License Agreement, STR Distributor grants You a non-exclusive and non-transferable License to use the Software in machine-readable executable code form only, for the purpose the Software is intended for, as well as the accompanying materials, for the License Period and without any right to sublicense or redistribute, may it be with or without charge.

Unless otherwise specified, STR Distributor will have the right to make any informative reference to the use by the End-User of the licensed STR Software, without prejudice to any confidential obligation that may exist between STR Distributor and the End-User.

STR Distributor will provide You with a hardware based key(s) (a dongle) and a license key code(s) linked to the dongle, that enable the Software for a License Period on the authorized number of computers in use or for the authorized number of processes running simultaneously. The dongle(s) shall be returned to STR Distributor within net ten (10) days the License Period expired unless it is extended or another license is issued for You by STR Distributor.

The scope of Your License depends on the type of a license You are granted by STR Distributor, and the variety of license scopes are set forth below.

#### (i) Trial License:

Under the control of a Trial License, You may Use the Software internally for the purposes of testing and evaluation only and only during the term of the trial period, which is specified in

the Trial License form, without any charge to You. STR Distributor strictly prohibits any kind of development activity or any other business activity using the Trial License without written permission of STR Distributor.

# (ii) Single-Node License:

Under the control of a Single-Node License, You may Install and Use the Software on an unlimited number of computers or computer nodes of a cluster located at the Designated Site, provided that only one computer/node is in use at any one time. If a parallel computation is realized in the Software, the number of concurrently used computers or computer nodes used for parallel processes of the computation, is equal to the number of the Single-Node Licenses You are granted from STR Distributor. The number of the processes of the Software that You are allowed to run on a single computer/node simultaneously might be limited as it is set forth in the Quotation of STR Distributor to You. A separate license is required for each additional concurrently used computer/node and/or number of the processes that You are allowed to run on a single computer/node simultaneously.

## (iii) Corporate License:

Under the control of a Corporate License, You may Install and Use the Software on an unlimited number of computers or computer nodes of a cluster located at the Designated Site of a single entity (corporation/organization) on no more than the authorized number of computers in use at any one time, or over a single Designated Network on a single central processing unit (server) by no more than the authorized number of concurrent users, as it is set forth in the Quotation of STR Distributor to You. A separate license is required for each additional Designated Site, computer and/or additional network where the Software is authorized to use, and/or for each additional user, and/or for additional number of processes that You are allowed to run on a single computer/node simultaneously.

#### (iv) License for Educational Use:

Any foregoing type of Licenses can be used under control of a License for Educational Use, offering special STR's discounted pricing, if You can be qualified as an Educational User. Only academic institutions or universities are eligible to be defined as Educational Users. Under the control of a License for Educational Use, You may Use the Software either for educational or non-commercial research purposes only. Any work performed or produced as a result of use of the Software cannot be performed or produced for the benefit of other parties for a fee, compensation or any other reimbursement or remuneration; any such use of the Software will be identified as a "commercial use". Using the Software under the License for Educational Use for the benefit of industrial companies may it be with or without charge, will be considered also as a commercial use.

Any public evidence on commercial use of the Software under the License for Educational Use, including but not limited to the articles presenting the results obtained with the use of STR Software and published by the End-User in co-authorship with the authors from industrial companies, will be indicative of commercial use of the Software.

In case the fact of commercial use of the Software under the License for Educational Use is revealed and proved by STR Distributor, You will be charged for extra payment equal to the discount provided to You as an Educational User. Until the full commercial price for the Software is paid, the support services, as specified in Section 5 below, will not be provided to

## 3. Delivery of Software

The access to the Software is provided electronically by downloading the respective software products from the corporate server of STR together with the accompanying documentations: user manual, theory manual, examples of calculations, etc. On the request from You, the installation version of the Software might be delivered on medium.

The dongle will be shipped to the place designated in the Quotation of STR Distributor to the End-User. The delivery will also consist in the remittance of license key code that will allow You to use the Software, and contact information to receive support services.

For the period within the term of payment a temporary license might be issued for You which is extended to the whole license term as soon the License Fee is paid to STR Distributor in full. The term of the temporary license is taken into account within the License Period.

In case of a several years long License, the license key code that is linked to the particular dongle is issued for an annual term which is extended for the consecutive annual term on receipt of confirmation from the End-User unless otherwise agreed on in writing with the End-User.

#### 4. License Restriction

- A. THIS SOFTWARE IS NOT DESIGNED, INTENDED, OR AUTHORIZED FOR USE IN THE DESIGN, FABRICATION, OR IMPLEMENTATION OF ANY MEDICAL, LIFE SAVING OR LIFE SUSTAINING SYSTEMS, OR FOR ANY OTHER APPLICATION IN WHICH ANY FAILURE OF ANY PORTION COULD CREATE A SITUATION WHERE PERSONAL INJURY OR DEATH MAY OCCUR. If the Software is used for any such unintended or unauthorized use, STR Distributor shall be harmless against all claims, costs, damages, and expenses arising out of, directly or indirectly, personal injury or death associated with such unintended or unauthorized use.
- B. By receiving a first copy of the Software electronically, and a second copy on medium, You may use only one medium that is applicable for the type of License You are granted from STR Distributor and utilize the second copy only for backup or archival purposes. You may not provide the second copy to another user.
- C. You may NOT: (i) use or copy the Software except as provided in this License Agreement; (ii) rent, lease, lend, sublicense, or otherwise convey the Software to any third party; (iii) assign this License Agreement or transfer the Software without the express prior written consent of STR Distributor; (iv) modify, adapt, or translate the Software in whole or in part; (v) remove any proprietary notices from the Software or the user documentation; (vi) reverse engineer, decompile, disassemble or debug the Software; (vii) attempt to modify, disable, or tamper with the normal function of the internal license manager that regulates usage of the Software.
- D. In publications of the results obtained through the use of the Software, You shall refer the STR Software used in calculations unless otherwise agreed on with STR Distributor in writing prior the publication.

## 5. Support Services

STR Distributor will provide You with Support Services related to the Software for the License Period. The Support Services include:

- (a) Providing Installation support;
- (b) Amendment of the Software if any defects or bugs preventing the normal operation of the Software are revealed:
- (c) Reasonable e-mail and phone technical support on the use of the Software, help in the interpretation of results obtained;
- (d) Update and Upgrade of the Software. Any Updates or Upgrades of the Software made during the License Period will be accessible for You. You may refuse to accept the renewed Software. By accepting it, You agree to destroy all prior copies and versions of the Software. The conditions outlined in this License Agreement are transferred to the renewed Software.

Any supplemental software program or documentation or other information provided to You by STR Distributor as part of the Support Services shall be considered to be part of the Software and subject to all of the terms and conditions of this License Agreement.

#### 6. Confidential Information

STR Distributor and You shall be obligated to keep secret any information or documents communicated between the two and marked as "Confidential Information" or "Proprietary" or "Trade Secret" and to use such information and documents only in the scope defined in this License Agreement. STR Distributor and You shall impose corresponding conditions upon their own employees, suppliers, agents, consultants, and other third parties having access to the Software to the extent this has not already been done.

The obligation to maintain secrecy regarding the information communicated to one another shall not apply to the extent that:

- (a) The information was known to the informed party prior to communication and there is an evidence of that;
- (b) The information was publicly known or generally accessible prior to communication;
- (c) The information becomes publicly known or generally accessible after communication without contributory or negligent action on the part of the informed party;
- (d) The information corresponds substantially to such information as is revealed or made accessible to the informed party by an authorized third party at any time whatsoever.

This provision shall be in addition to, and not in lieu of, any other existing confidentiality obligations between the parties hereto. In the event of a conflict between the terms and conditions set forth under this Section 6 (Confidential Information) and the terms and

conditions set forth under another existing confidentiality obligation between the parties, the terms and conditions set forth under the other existing confidentiality obligation shall prevail.

## 7. Intellectual Property

STR Software products are protected by the national laws and international treaties on copyright. The unlawful copying and utilization of STR Software is constitutive of an infringement act.

Any act of infringement by the End-User of STR Software or any act, of which the End-User may have become aware of, should be notified by the End-User to STR Distributor who shall then decide which procedure to follow.

STR Distributor represents and warrants that it has full power to enter into this License Agreement entitled by the owner of the intellectual property rights for the STR Software, and further warrants that it is not aware that STR Software infringes any patent, copyright or other proprietary right of any third party and that it has not been notified by a third party of a possibility that STR Software might infringe any patent, copyright or other proprietary right of any third party.

#### 8. Indemnification Obligations

STR Distributor agrees to indemnify and defend the End-User from and against any claims or proceedings initiated by a third party alleging that the STR Software (or the End-User's use thereof) infringes or misappropriates a third party's intellectual property provided that the End-User promptly notifies STR Distributor in writing of any action or claim and provides full information and reasonable assistance required to defend such suit, claim or proceeding, at no expense to the End-User. Notwithstanding the foregoing, in no event will STR Distributor enter into any settlement that obligates the End-User to make an admission of guilt or incur any expense for which the End-User is not indemnified, without the End-User's prior written consent.

Should the Software become or is likely to become, the subject of any claim, STR Distributor, at its option and expense, either: (a) procure for the End-User the right to continue to use the Software as contemplated by this Agreement, (b) replace or modify the Software to make its use in accordance with this Agreement non-infringing, or (c) terminate this Agreement and provide the End-User with a refund of all fees paid hereunder (if any), less reasonable depreciation based on usage.

## 9. Limited Warranty

STR Distributor warrants that: (i) The dongle providing protection and licensing the STR Software will be free of defects in materials and operation under normal use; (ii) the Software substantially conforms to the Description of the Software supplied with the Software, and (iii) the Support Services provided by STR Distributor shall be substantially as described in this License Agreement.

The defective dongle will be replaced with a new one without any charge to You, if it is returned back to STR Distributor. In case the dongle is lost at Your side after the license key code is issued by STR Distributor, it will be replaced with a new one only in case the force majeure circumstances as specified in Section 11 below, resulted in the loss, are evidenced by the independent expertise provided by You.

Except for the foregoing, the Software is provided AS IS. This limited warranty extends only to You as an original licensee. In no event does STR Distributor warrant that the Software is error free or that You will be able to operate the Software without problems or interruptions. STR Distributor does not guarantee the correctness or usefulness of the results You obtained using the STR Software. STR Distributor is not liable for any conclusions or actions based on the results You obtained. This is Your responsibility to confirm the accuracy and usefulness of the results.

The above warranty DOES NOT apply to any beta software, any software made available for testing or demonstration purposes, or any temporary software modules. All such software products are provided AS IS without any warranty whatsoever.

## 10. Limitations of Liability

EXCEPT FOR THE INDEMNIFICATION OBLIGATIONS STATED IN SECTION 8 ABOVE AND VIOLATION OF THE CONFIDENTIALITY OBLIGATIONS STATED IN SECTION 6 ABOVE, IN NO EVENT SHALL STR DISTRIBUTOR BE LIABLE FOR ANY SPECIAL, INCIDENTAL, INDIRECT, OR CONSEQUENTIAL DAMAGES HOWEVER CAUSED (INCLUDING, WITHOUT LIMITATION, DAMAGES FOR LOSS OF **BUSINESS** PROFITS, **BUSINESS** INTERRUPTION, LOSS OF **BUSINESS** INFORMATION, OR ANY OTHER PECUNIARY LOSS) ARISING OUT OF THE USE OF OR INABILITY TO USE THE SOFTWARE, OR THE PROVISION OF OR FAILURE TO PROVIDE SUPPORT SERVICES, EVEN IF STR DISTRIBUTOR HAS BEEN ADVISED OF THE POSSIBILITY OF SUCH DAMAGES.

EXCEPT FOR VIOLATIONS OF THE LICENSE RESTRICTIONS STATED IN SECTION 4 ABOVE, OR THE CONFIDENTIALITY OBLIGATIONS STATED IN SECTION 6 ABOVE, IN NO EVENT SHALL YOU BE LIABLE FOR ANY SPECIAL, INCIDENTAL, INDIRECT, OR CONSEQUENTIAL DAMAGES HOWEVER CAUSED (INCLUDING, WITHOUT LIMITATION, DAMAGES FOR LOSS OF BUSINESS PROFITS, BUSINESS INTERRUPTION, LOSS OF BUSINESS INFORMATION, OR ANY OTHER PECUNIARY LOSS), EVEN IF YOU HAVE BEEN ADVISED OF THE POSSIBILITY OF SUCH DAMAGES.

#### 11. Force Majeure

You shall not be liable for the loss of the dongle if the loss resulted from the events or circumstances outside Your reasonable control, including but not limited to accidents, fire, flood, war, breakdown of facilities, and You shall be entitled to a replacement of the dongle at a price of device and delivery charge without any penalties to You.

### 12. Applicable Laws

Your local law, both for its interpretation and for its enforcement, shall govern the present License Agreement.

#### 13. Term and Termination

The License under this License Agreement becomes effective on the date You accept this License Agreement by loading the Software and will continue until terminated as provided for in this License Agreement. The License under this License Agreement will terminate upon a thirty (30) days' notice from STR Distributor if You fail to comply with any material provision of this License Agreement and You fail to cure the material breach within the thirty (30) day cure period. Upon termination, You must destroy the Software together with all copies, adaptations and portions in any form.

## 14. Severability and Waiver

If any provision of this License Agreement is held to be illegal, invalid or otherwise unenforceable, the remaining provisions will remain in full force and effect.

The waiver by either party of any default or breach of this License Agreement will not constitute a waiver of any other or subsequent default or breach.

## 15. Entire Agreement

This License Agreement may not be modified or amended except in a writing signed by a duly authorized representatives of the parties. In case of any written documents concerning the use of STR Software, a subject matter of this License Agreement, are signed between the parties, the provisions of those documents will be prevailing.

If You agree to the terms of the above License Agreement, click to download the STR Software.

If You already have the Software downloaded or otherwise possessed, running the Software shall mean You to agree to the terms of the above License Agreement.
